1. **Duhabi Municipality** invites bids for the supply of *various Goods for Duhabi Municipality* towards the cost of 87,82,800 *Excluding VAT [Supplying of Electric motor with pump and its related accessories for kisan/krishak Samuh for boring at Duhabi Municipality]* and intends to apply part of the funds to cover eligible payments under the Contract for **DM/NCB/Goods/2083/084-01** Bidding is open to all eligible Bidders from all countries as defined in ITB Clause 4 (Eligible Bidders)..
2. The **Duhabi municipality** invites *[electronic only]* bids from eligible bidders for the procurement of *[Supplying of Electric motor with pump and its related accessories for kisan/krishak Samuh for boring at Duhabi Municipality]* under National competitive bidding – Single Stage Single Envelope procedures.
*[Note: In case of IFB to be published as slice/package/lot basis the Purchaser may add following information:
The bidder may submit the bid for single or more packages/lots as mentioned below and offer discounts/ cross discounts. Evaluation will be done for each package/lot, with contracts awarded based on the award combination that is of least cost to the Purchaser.]*
3. Eligible Bidders may obtain further information and inspect the bidding documents at the office of *[Supplying of Electric motor with pump and its related accessories for kisan/krishak Samuh for boring at Duhabi Municipality]* or may visit PPMO egp system www.bolpatra.gov.np/egp.
4. 5. Pre-bid meeting shall be held at **[Duhabi Municipality Duhabi Sunsari]** at **[2026 Aug 20]**²
6. Sealed or electronic bids must be submitted to the office **[Duhabi Municipality Duhabi Sunsari]** by hand/courier or through PPMO's e-GP system www.bolpatra.gov.np/egp on or before **[12:00 PM]** on **[2026 Aug 31]**. Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at**[13:00 PM, 2026 Aug 31]** at the office of**[Duhabi Municipality Duhabi Sunsari]**. Bids must be valid for a period of**[120 days]** from the bid submission deadline and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NPR **2,20,000 [Two lakh twenty thousand only]**, which shall be valid for 30 days beyond the validity period of the bid **[120 days]**
8. If the last date of purchasing and /or submission falls on a public holiday³ applicable to purchaser, then the next working day shall be considered as the last date. In such case the validity period of the **bid and** bid security shall remain the same as specified for the original last date of bid submission.
